Arraignment set in malnourishment case

Holden Police have confirmed that the department is working on a case involving a Holden couple who will be arraigned July 21 in Leominster District Court on charges involving their malnourished 2-year old.

"I still consider it an active and open investigation," Holden Police Chief George Sherrill said. "We're working with the Worcester County DA's office and [Department of Social Services]."

As an active investigation and one in which arraignments have not yet occurred, neither Sherrill nor the Worcester County District Attorney's office could confirm details of the case.

According to a Worcester Telegram & Gazette story last week, Kellie and Joshua Theriault of 1588 Main St. face charges of reckless child endangerment. In February, a Holden police officer, acting on an anonymous call made to DSS, went to the home and saw bruises on the boy's face, the story said. The child weighed 17 pounds.

The boy was removed and placed in foster care.
